The highlights of Monetary Policy for fiscal year 2075/76 are promotion of investment in productive sectors, control of interest rate and encouragement for financial institutions to go for merger. There is a preparation for real estate price index. The policy has tightened loan for real estate. Banks have to provide loan for real estate by looking at the earning. It's a mixed blessing. There will be calculated amount of cash flow into the market, which ensures real buyers, instead of speculations. The much talked about index estate price stabilize definitely help the market.

The Government has adopted National Land Policy 2019 to manage lands in a sustainable Source: The Himalayan Times 18 March 2019, Naya manner through Land Use Plans (LUPs). It's for optimum use and protection of arable lands by discouraging non-agricultural use of arable lands and the trend of keeping land uncultivated and rampant fragmentation. Basic Guidelines relating to human settlement, urbanization plans and building constructions in the classified lands, and minimum standards of basic infrastructure, greenery and open spaces/zones shall be prescribed in line with Building Code. The Act permits authorities to impose fines if land is not used for specific purpose

to land bank, which was brought to cultivate arable land. Under the concept, landowners could deposit uncultivated land for a certain time in the bank and interested people or group

The Ministry of Land Management has announced that it will expand online services to all the Land Revenue Offices across the country within a year. The government has plans also to introduce online services in offices of the Survey Department in Kathmandu Valley within the current fiscal year and across the country within the next fiscal year. Various details of landowners will be registered in the system, which is expected to save landowners from possible cases of land fraud.

These policies will surely bring positive vibes while guiding next level of urbanization and market. We can only hope that the government and banks become just as positive in coming
